We have two ground storage tanks a 400,000 gallon and a 500,000 gallon located in Aspermont in Stonewall County where we chlorinate our water there again. Just west of those GST we have our pump house and here we pump water to town and fill our 100,000 gallon elevated storage tank in the middle of Aspermont.
