

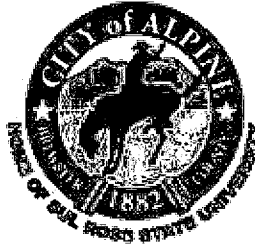

As required by Senate Bill 3, The City of Alpine is providing the Public Utilities Commission of Texas information pertaining to the City's water and wastewater utilities.



Alpine is a remote, rural community. Included are several maps of the locations of both water and wastewater components, latitude and longitude, and service addresses to assist with identifying and locating. The wastewater plant is located approximately 2.5 miles Northeast of North Highway 118. This is the only wastewater treatment plant serving the residents and businesses of Alpine. The system is gravity designed with the addition of several lift stations to ensure continued flow. There are four lift stations, three primarily located in the East portion of Alpine and one on the Southside.

Water operations consist of two main well fields (Roberts and Musquiz) and multiple storage tanks (Upper Hill, Lower Hill, Alpine, Musquiz, Sunny Glen, Pearce, East and Sul Ross Tanks). Roberts Wells are located northwest of the City of Alpine, in the Sunny Glen addition. Musquiz Wells are located north of the City of Alpine, in Jeff Davis County. Note: latitude and longitude of the locations of each well and tank are included.

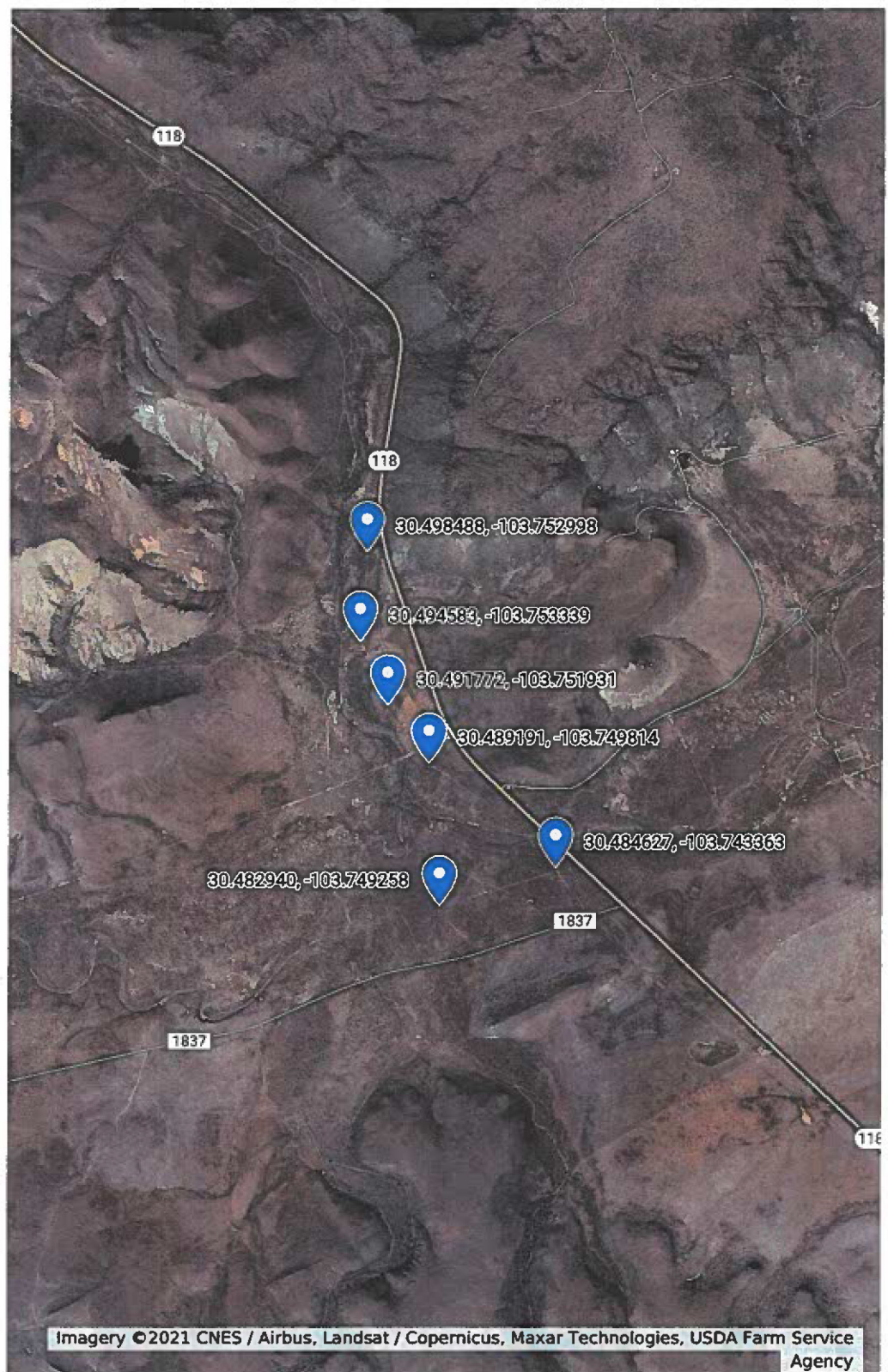

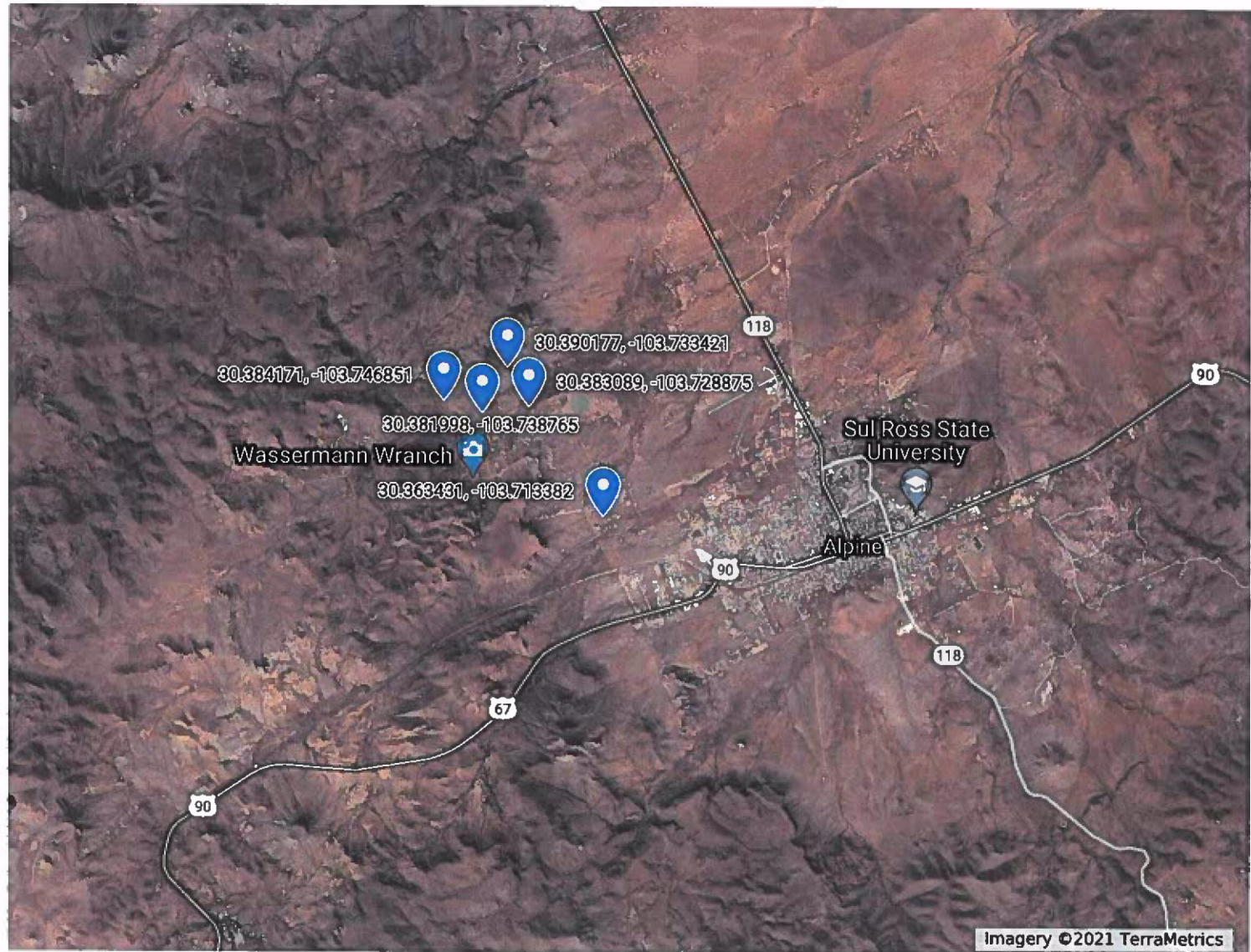
