The City of Muleshoe Municipal water System owns and operates the following public water system that can be classified as an affected utility in Texas Water Code§ 13. 1394.

The public Water System serves a population of 5,200 people.

The system is comprised of two well fields, two booster stations, One main lift station, and one wastewater treatment plant. There are two different providers that provide power to various facilities, Xcel Energy, and Bailey County Electric Cooperative.

Sanderosa Well field is located 1.5 miles South HWY 214 it is comprised of 12 wells and 5.6 of transmission lines. This well field is serviced by Bailey County Electric Corporation.

South Well field is located 1.4 miles South HWY 214 it is comprised of 7 wells and 2.1 miles of transmission lines. This well field is served by both electric providers, Xcel Energy and Bailey County Electric Cooperative.

Booster Station # 1 is located at 745 St HWY 214 or 1,3 Miles south on HWY 214. It is at this location that the water from the well fields is stored and disinfected before it is pump to the elevated storage tanks in town. The city can store and treat 700,000 gallons at this location.

Wastewater treatment plant is located 2.5 miles south on HWY 214. The treatment plant Is rated to treat 750,000 gallons of sewer per day.

The main wastewater lift station is located at 1000 East 4th. The city's sewer collection system flows by gravity to this location. Wastewater is pumped to the treatment plant from here.

All these components are critical infrastructure and should be included in the critical load status.
