To Central Records:

The purpose of this letter is to provide the City of Leander Water Utility's specific information for compliance with the Public Utility Commission of Texas (PUCT) Project 52299 – Senate Bill 3 Texas Water Code (TWC) § 13.1396.

TWC § 13.1394, defines an "affected utility" as a retail public utility, exempt utility, or provider or conveyor of potable or raw water service that:

- *Furnishes water service to more than one customer; and*
- *Is not an affected utility under Section 13.1395.*

The City of Leander Utilities Department meets the definition for an affected utility and is required to file this information with the PUCT. The following information for the affected utility must also be filed with each transmission and distribution service provider, each retail electric provider, the Texas Division of Emergency Management, and the office of emergency management of each county where the utility has water or sewer facilities that qualify for critical load status.

The information required to be filed includes the location and general description of all water and sewer facilities that qualify for critical load status, attached hereto as Attachment 1. Other information required to be filed includes the emergency contact information for the affected utility:
