To the Project Administrator,

The Bolivar Peninsula Special Utility District, PWS ID 0840044, in compliance with SB 3, attests that we are capable of continued operation in the event of a power outage exceeding 24 hours in duration.

The BPSUD office at 1840 Highway 87, Crystal Beach, TX 77650 is equipped with a permanently mounted 100 kW generator to provide the needs created by office operations. We also have a 40 kW generator for warehouse needs and our 1 million gallon elevated storage tank (EST), currently under construction, behind our office.

Our High Island South plant at 1265 Highway 124, High Island, TX 77623 has a permanently mounted 230 kW generator on site to serve a 1 M gallon ground storage tank (GST), .25 M gallon EST, three 1500 GPM pumps and one 400 GPM pump.

The High Island North plant at 1957 Guidry, High Island, TX 77623 has a permanently mounted 350 kW generator for a .5 M gallon GST and a 15,000 gallon Pneumatic tank.

Our Singing Sands plant at 3597 Highway 87, Crystal Beach, TX 77650 has a permanently mounted 500 kW generator for our 2 M gallon GST and three 2350 GPM pumps.

Our Port Bolivar plant at 4339 Highway 87, Port Bolivar, TX 77650 has a permanently mounted 300 kW generator for the 1 M gallon GST, .5 M gallon EST, three 1300 GPM pumps and one 400 GPM pump.

We also have a 300 kW portable generator as a backup. All generators are under a third part service contract for routine maintenance.

In addition, our office has been in touch with our energy provider, Entergy, to establish our status as a Critical Care Customer. That relationship was requested and confirmed via telephone



conversations in August 2021. The critical load designation was requested for each physical location we are billed for by Entergy. The electric utility representative stated that he was not able to provide written confirmation of the status.
