To Whom It Concerns:

Alliance Regional Water Authority (Alliance Water) is a wholesale water provider of potable water to the City of Buda water system and therefore meets the definition of an "affected utility" per Texas Water Code (TWC) §13.1394. Alliance Water's Buda Booster Pump Station Facility qualifies as a facility that should be included as a critical load status. Below is the information required by TWC §13.1396 regarding the facilities and Alliance Water's contact information.

Facility General Description

Alliance Water's Buda Booster Pump Station (BBPS) receives water from the City of Kyle in its ground storage tank and pumps that water to the City of Buda for use in their distribution system. Alliance Water is in the process of completing projects to bring a new water supply to the region that will be the long-term source of water to the BBPS.

The pump station facility consists of a 750,000 gallon ground storage tank with three thirty horsepower vertical turbine pumps. Electrical service to the site is three-phased and is provided by the Pedernales Electric Cooperative. The pump station includes a 175 kilowatt diesel emergency generator with a fuel tank sized to provide 24 hours of fuel storage at maximum load. An automatic transfer switch switches the power between the utility power and the emergency generator.


