This letter is to inform/comply to the new TWC 13.1394 rule for an affected utility. The name of our water system is as stated above or Bell County WCID #2. We currently contract operations of our system with Operations Management International / Jacobs Engineering. Our utility includes: water treatment plant at 202 South Brookman, Little River Tx76554. Raw well water is pumped and treated with liquid ammonium sulfate and gas chlorine and then blended with purchased water from the City of Temple. Current average daily flow is 165,000 per day. We are under contract with the City of Temple to provide us 30 MG of water per year.

Little River Wastewater Treatment Plant located at 610 South Evans, Little River Tx 76554. Designed to treat .16 MGD.

Academy Wastewater Treatment Plant located at 206 South Evans, Little River Tx 76554.Desigened to treat .10 MGD

We also have four lift stations that pump sewage to the Little River WWTP. They are Daniels Lift Station at Church Street and FM 436, Arbors Lift Station at 100 Arbor Drive, Buckley MHP Lift Station off Buchanan Drive and Brookman Lift station off South Brookman Drive.

All of our accounts are listed as critical load with Oncor Electric Delivery.


