This letter is to comply with Project 52299, Senate Bill 3 of the 87th State Legislature, Regular Session and to advise parties that the City of Pleasanton Water and Sewer utilities meet the Texas Water Code §13.1394 definition of an "affected utility". Per §13.1396 of the Texas Water Code, the City is providing general information on the critical load infrastructure required by the water and sewer utilities.

The City of Pleasanton serves a population of over 11,000 people and industry in Atascosa County.
