This letter is written in response to the PUCT Project 52299 and Senate Bill 3, 87th Legislature, Regular Session Compliance Guidance-Texas Water Code (TWC) §13.1396.

The City of De Leon is a small municipality that currently operates three facilities that qualify as an affected utility. They are as follows:

The City of De Leon Wastewater Treatment Plant located at 1402 E. Navarro Street, De Leon Texas 76444. This facility treats all of the wastewater from the City of De Leon.

The City of De Leon Ross Street Lift Station located at 1015 E. Ross Avenue, De Leon, Texas 76444. This facility serves as the wastewater pumping station for multiple households located at a lower elevation on the far eastern side of De Leon.

The City of De Leon Elevated Storage Tank located at 201 W. Wofford Street, De Leon Texas 76444. This facility serves as the main storage and treatment point for our Public Water System. It is also provides our system with the mandatory pressure requirement.
