To Whom It May Concern:

Utility Engineering Group, PLLC (UEG), on behalf of the City of Marion, is filing this letter as required by the Texas Water Code (TWC) §13.1396(c) and Texas Senate Bill 3, per the Texas 87<sup>th</sup> Legislature. In accordance with TWC §13.1394, Marion is classified as an "affected utility" and is required to submit to the utility commission, each electric utility that provides transmission and distribution service to the affected utility, each retail electric provider that sells electric power to the affected utility, the office of emergency management of each county in which the utility has water and wastewater facilities that qualify for critical load status under rules adopted by the utility commission, and the division of emergency management of the governor information identifying the location and providing a general description of all water and wastewater facilities that qualify for critical load status; and emergency contact information for the affected utility.
