To Whom It May Concern:

Walker Partners Engineers & Surveyors has been contracted on behalf of the Schertz Seguin Local Government Corporation (SSLGC) to assist in completing the requirements of Senate Bill 3. As an affected utility, the SSLGC is providing critical load status information for their water distribution and treatment assets along with emergency contact information for compliance with Senate Bill 3 of the 87th Legislature of the State of Texas and Texas Water Code §13.1396.

The LCRA generates and transmits power, then GVEC distributes the power to its customers which includes SSLGC's facilities. GVEC is a transmission customer who has their own equipment at LCRA substations. CPS Energy generates and transmits power as well as distributes the power to its customers which includes SSLGC's facilities.

Table 1 is a list of the Critical Load Status Facilities with descriptions and each location. All these facilities are shown on a map in **Exhibit 1**. *Table 2* details the emergency contacts.
