

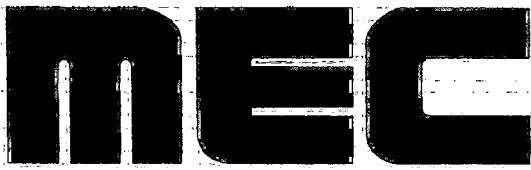

Public Utilities Commission of Texas, Austin Energy- City of Austin Utilities, Travis County Office of Emergency Management, and the Texas Division of Emergency Management:

On behalf of Travis County Municipal Utility District No. 4 (Master District for Travis County MUD No.’s 3, 4, 5, 6, and 8), which are all defined as an “affected utility” under TWC § 13.1396, Murfee Engineering Company, Inc. is filing this letter of compliance to meet the requirements of Texas Senate Bill 3.
