Dear Public Utility Commission of Texas,

CSWR-Texas Utility Operating Company, LLC ("CSWR Texas"), the Texas-based affiliate of CSWR, LLC, currently owns and operates 33 retail water and wastewater systems serving the public and is an "affected utility" under Tex. Water Code § 13.1394. The attached exhibits include all information requested from affected utilities by the Public Utility Commission of Texas in Project No. 52299.

Contemporaneously with this filing, CSWR Texas is providing the same information to (1) the transmission and distribution utility for each water or wastewater system, (2) each retail electric provider for those water or wastewater systems located in ERCOT, (3) the office of emergency management of each county where a water or wastewater system is located, and (4) the division of the emergency management of the governor via email at soc@tdem.texas.gov.


