To Whom It May Concern,

Violet Water Supply Corporation is providing this letter in accordance with the Public Utility Commission of Texas (PUCT) Project 52299 (affected utilities). Violet Water Supply Corporation (VWSC) provides potable water services to approximately 930 residential connections in three separate pressure zones, Northern Zone (Pressure Zone 1), Central Zone (Pressure Zone 2), and the Southern Zone (Pressure Zone 3). The Northern Zone is under direct pressure from the City of Corpus Christi, and the Central and Southern zones are provided pressure through the facilities outlined below.

## Water Facilities are located as noted below:

- FM 1694 Pump Station (Central Zone), located along FM 1694, Robstown Texas 78380
  - Consists of a 100,000 gallon ground storage tank, a 3,500 gallon hydropneumatics tank, and three (3) 1,000 gpm pumps. This pump station provides potable water to VWSC's central zone, the existing 50,000 gallon elevated storage tank, and to fill the ground storage tank in the southern zone. This pump station is a single-electric feed facility with no on-site generator; however VWSC has one (1) trailer mounted generator that can be used to run of the two pump stations during an outage.
- FM 665 Pump Station (Southern Zone), located south of FM 665 and east of CR 67, Robstown Texas 78380
  - Consists of two (2) 48,000 gallon ground storage tanks, two (2) 4,800 gallon hydropneumatic tanks, and three (3) 500 gpm pumps. This pump station provides potable water to the southern zone of the VWSC system. This pump station is a single-electric feed facility with no on-site generator, however VWSC has one (1) trailer mounted generator that can be used to run one of the two pump stations during an outage
- 50,000 gallon elevated storage tank (Central Zone), located along CR 36.
