AWR Services, on behalf of Center for Christian Growth Camp, submits the following information in compliance with the Texas Water Code (TWC) § 13.1396 – Coordination of Emergency Operations.

1. Per the guidelines set forth by the Texas Commission on Environmental Quality (TCEQ), submission of an Emergency Preparedness Plan (EPP) for affected utilities is required on or before March 1, 2022. The EPP for the Center for Christian Growth Camp is currently in process as well as the TCEQ's notification of acceptance will be provided.
