To Whom it May Concern:

AWR Services, on behalf of Cypress Ranch WCID #1, submits the following information in compliance with the Texas Water Code (TWC) § 13.1396 – Coordination of Emergency Operations.

1. Per the guidelines set forth by the Texas Commission on Environmental Quality (TCEQ), submission of an Emergency Preparedness Plan (EPP) for affected utilities is required on or before March 1, 2022. The EPP for the Cypress Ranch WCID #1 is currently in process as well as the TCEQ's notification of acceptance will be provided.
2. The following water and wastewater facilities within Cypress Ranch WCID #1 qualifies for critical load status:
 - a. **Cypress Ranch Water Treatment Plant**
 - b. **Cypress Ranch Wastewater Treatment Plant**
 - c. **Cypress Ranch Lift Stations: Coral Bean LS, Chipotle LS, LS #4**
 - d. **Any water system facilities associated with TX2270352 as identified by address on Exhibit A attached.**
