IN THE MATTER OF: City of Conroe - Request for Critical Load Status Updated

The City of Conroe has filed a request for critical load status for water and wastewater facilities as required of affected utilities. The City of Conroe has one active Public Water System PWS1700001 and one active Wastewater Treatment Plant, Permit number WQ0010008002. The list of facilities with the service address and description is attached.

Entergy is both the TDU and retail provider of electricity for the City water and wastewater facilities. The request was received by Entergy September 27, 2021. The City submitted the SB3 information to PUCT based on the initial confirmation of receipt. On November 1, 2021 Entergy provided confirmation that the City's facilities have been added to their "critical load status" list. I am re-submitting today with this confirmatory email from Entergy.

The emergency contact for the Water and Wastewater facilities is Jason Miller, Assistant Director of Public Works for the City of Conroe. The secondary contact is Christine Santiny, Utility Manager. The 24-hour telephone line for Public Works is 936-522-3885 and is answered either by Police Dispatch or Public Works personnel. This is the best way to contact Public Works in an emergency.

We have a new regulatory requirement that was passed during the last legislative session post winter storm Uri. The attached Fact Sheet describes what each water and wastewater provider must do before Nov 1. It is a little confusing but the PUC told us in the training session that we have to apply with both our TDU and retail electric service provider for critical load status for our facilities. This is known commonly as the type of status that hospitals have for restoration and maintenance of power. We need to formally apply and receive approval from our TDU and retail electric service provider. Do you have an application form?
