COMES NOW, the City of Terrell (City), by and through its undersigned attorneys of record, and files this Response to Rose Hill Special Utility District's (District) Third Requests for Information (RFIs) 3-1 through 3-5 and 3-9. Pursuant to 16 Texas Administrative Code § 22.144(c)(2)(F), the City agrees and stipulates that all parties may treat the responses as if the answers were filed under oath. The parties conferred about the City's objections to the District's Third RFIs, and on January 24, 2024, the District delivered its Amended Third Requests for Information to the City. The parties were not able to resolve the City's objections to RFIs 3-6, 3-7, and 3-8, thus the City filed its objections to RFIs 3-6 through 3-8 that same day. The District did not file a Motion to Compel responses to RFIs 3-6 through 3-8. On February 2, 2024, the parties filed a Fourth Amended Rule 11 Agreement, agreeing to a deadline of February 16, 2024, for the City to supplement its response to RFI 2-10, respond to RFIs 2-1 through 3-5, and RFI 3-9 with the information provided herein.

**ROSE HILL 3-9** 

If the City alleges that Rose Hill has consented in writing to changes to or the amendment of Rose Hill's CCN to decertify or transfer all or part of the 232-Acre Area from Rose Hill's CCN to the City's certificated area, please state the facts upon which the City relies in support of this allegation.

**RESPONSE:** 

The District's predecessor, Rose Hill Water Supply Corporation (Corporation), signed a certain Memorandum of Agreement, dated February 25, 2005, with the City which states "The Corporation will allow the City to acquire a portion of the Corporation's CCN covering the Terrell Market Center, comprising of approximately 181.5 acres. As part of the sale, transfer or merger application to the TCEQ, the Corporation will also consent to the transfer to the City the portion of the Corporation's CCN area which includes the Tanger Outlet Center." In exchange, the City agreed to support legislation to convert the Corporation into the District and transfer the rights to 39 million gallons per year of water supply capacity for the corporation to receive from North Texas Municipal Water District.

The District signed a certain Memorandum of Agreement, dated October 21, 2008, with the City which states "The District will decertify the portion of the District's [water CCN] covering the area north of CR 305 and west of CR 304 but south of Interstate 20 (approximately 350 acres) ... [and] the acreage owned by Randall Noe ... at the southeast intersection of Rose Hill Road and Interstate 20." The District also agreed it "will decertify the CCN area owned by Estess, Sheid, Arnold ... located south of the Tanger Outlet Mall that currently is in Rose Hill's CCN and transfer to the City in exchange for the 680 foot long, 30 inch diameter water encasement ... that runs under I-20 at CR 305." In exchange, the City also agreed to transfer the rights to an additional 61 million gallons per year of water supply capacity for the District to receive from North Texas Municipal Water District, to be added to the original 39 million gallons per year to make the total transfer 100 million gallons per year.
