
On February 22, 2024, the District filed its Fourth Requests for Information (RFI). Pursuant to 16 Texas Administrative Code § 22.144(k), the parties may modify deadlines for responses by agreement by filing a letter or other document evidencing the agreement. The City requires additional time for its sponsoring witnesses to review the responses to the Fourth RFIs. Therefore, the City and the District agree to extend the City's deadline to respond to the District's Fourth RFIs to Friday March 15, 2024.


