ROSE HILL SPECIAL UTILITY DISTRICT'S PETITION FOR CEASE AND DESIST ORDER AGAINST CITY OF TERRELL

COMES NOW, Rose Hill Special Utility District ("Rose Hill"), and files this Petition for Cease and Desist Order against the City of Terrell, Texas ("City"), for providing unauthorized water service and interfering with Rose Hill's water system, pursuant to Texas Water Code ("TWC") §§ 13.242 and 13.252, and 16 Texas Administrative Code ("TAC") § 24.255. In support thereof, Rose Hill respectfully shows the following:

3. Description of Unlawful Provision of Service and Interference (16 TAC § 24.255(a)(3))

The City is providing retail water service to customers within a 232-acre area in Kaufman County that is solely situated within the boundaries of Rose Hill's CCN (CCN No. 10849). The City is doing so without Rose Hill's consent and without any approval from the Public Utility Commission of Texas ("PUC"). These actions by the City are in violation of TWC §§ 13.242 and other applicable statutes and regulations.

Rose Hill is capable of providing adequate and continuous water service to the customers within in the area that is being unlawfully served by the City. Rose Hill has water lines that are approximately 300 to 500 feet away from such customers and Rose Hill is able to extend those lines to deliver water to those customers.

4. Map of Service Area of Requesting Utility that Clearly Shows Location of the Unlawful Provision of Service (16 TAC § 24.255(a)(4))

Exhibit A is a map of Rose Hill's service area which clearly shows the location in which the City is unlawfully providing water service.

5. Additional Information

Rose Hill notified the City of this unauthorized provision of water service on April 28, 2021, through a representative of the City, and again on May 28, 2021, through the City's outside counsel.

Conclusion and Prayer

Based on the foregoing, Rose Hill Special Utility District respectfully requests that the Public Utility Commission of Texas issue an order requiring the City of Terrell to cease and desist its unauthorized retail water service to the area identified in this petition. Rose Hill also respectfully requests that the PUC issue an order prohibiting the City of Terrell from extending or providing water service to any other customers located within Rose Hill's CCN No. 10849.
