**COMMISSION STAFF'S REQUEST FOR AN EXTENSION**

On July 14, 2021, Bastrop West Water Supply (Bastrop West) and K & K Water Company (K & K Water) (collectively, applicants) filed an application for approval of the sale and transfer of facilities and certificate rights in Bastrop County. The Applicants seek approval to sell and transfer all of Bastrop West's facilities and certificated service area under water Certificate of Convenience and Necessity (CCN) number 12050 to K & K Water's water CCN number 11836. The requested area consists of approximately 900 acres and 117 customer connections. The applicants filed supplemental information on July 27 and August 11, 2021.

On July 15, 2021, the administrative law judge (ALJ) filed Order No. 1, establishing a deadline of August 13, 2021 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application, proposed notice, and to propose a procedural schedule for further processing of this docket. Therefore, this pleading is timely filed.

**I. REQUEST FOR AN EXTENSION**

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to conduct its review of the application and supplemental information filed on August 11, 2021. Accordingly, Staff respectfully requests the entry of an order extending the deadline for Staff to file its comments on the administrative completeness of the application until August 27, 2021.

**II. CONCLUSION**

Staff respectfully requests the entry of an order extending Staff's deadline to August 27, 2021 to file its comments on the administrative completeness of the application.
