**THE COALITION OF COMPETITIVE

MOTION TO INTERVENE**

The Coalition of Competitive Retail Electric Providers (“CCR”) files this Motion to Intervene on behalf of the identified Retail Electric Providers (“REPs”) and respectfully requests that it be granted party status in this proceeding.¹

I.

The CCR seeks to participate in the above-captioned proceeding on behalf of the identified REPs pursuant to Public Utility Commission ("Commission" or "PUC") PROC. R. 22.103 and 22.104. The CCR is comprised of retail electric providers certificated by the Commission to provide retail electric service in regions of Texas within the Electric Reliability Council of Texas ("ERCOT") and who are load-serving entities ("LSEs") and wholesale market participants that will be affected by the financing order sought in this docket. Additionally, ERCOT's request for an order initiating a parallel docket concerns collection of information from LSEs, and thus concerns and affects the identified REPs. Therefore, the CCR on behalf of its participating REPs has a justiciable interest that may be adversely affected by the outcome of this proceeding and should be granted party status.


