TO THE HONORABLE HUNTER BURKHALTER, ADMINISTRATIVE LAW JUDGE:

COMES NOW Tenaska Power Services Co. (“TPS”) and files this Proposal for Time Allotment. In support thereof, TPS shows the following:

I. BACKGROUND AND PROPOSAL

In Order No. 4, the administrative law judge (“ALJ”) directed parties participating in the Hearing on the Merits to provide their proposed time allotments by noon on Friday, August 20, 2021.¹ TPS is a party participating in the Hearing on the Merits, and therefore responds to Order No. 4 as follows:

TPS proposes that it be allotted 15 minutes total and that it be permitted to assign its time voluntarily, as has been the practice in prior Commission hearings. This proposal assumes the hearing schedule provided in Order No. 4 with a total hearing time of roughly 10.25 hours, excluding lunches and break time. TPS reserves the right to amend its proposed time allotment should the hearing schedule be modified to decrease or increase the total amount of time to be allocated.
