COMES NOW Calpine Corporation (“Calpine”), and files this Proposal for Time Allotment. In support thereof, Calpine shows the following:

I. BACKGROUND AND PROPOSAL


In Order No. 4, the administrative law judge (“ALJ”) directed parties participating in the Hearing on the Merits to file their proposed time allotments by noon on Friday, August 20, 2021.¹ Calpine is a party participating in the Hearing on the Merits, and therefore responds to Order No. 4 as follows:

Calpine proposes that it be allotted 1 hour total and that it be permitted to assign its time voluntarily, as has been the practice in prior Commission hearings. This proposal assumes the hearing schedule provided in Order No. 4 will consist of a total hearing time of roughly 10.25 hours, excluding lunches and break time. Calpine reserves the right to amend its proposed time allotment should the hearing schedule be modified to decrease or increase the total amount of time to be allocated.
