**GEXA ENERGY LP'S
MOTION TO INTERVENE**

Gexa Energy, LP (“Gexa”)¹ files this Motion to Intervene and respectfully requests that Gexa be granted party status in this proceeding.

I.

Gexa seeks to participate in the above-captioned proceeding pursuant to Public Utility Commission (“Commission” or “PUC”) procedural rules 16 TAC §§ 22.103 and 22.104. Gexa is a retail electric provider (“REP”) certificated by the Commission to provide retail electric service in regions of Texas within the Electric Reliability Council of Texas (“ERCOT”) and is a load-serving entity (“LSE”) and wholesale market participant that will be affected by the financing order sought in this docket.

Additionally, ERCOT’s request for an order initiating a parallel docket concerns collection of information from LSEs, and thus concerns and affects Gexa. Therefore, Gexa has a justiciable interest that may be adversely affected by the outcome of this proceeding and should be granted party status.




