**COMMISSION STAFF’S REQUEST FOR EXTENSION**

On July 16, 2021, Manvel Terrace Utilities, Inc. (Manvel Terrace) and the Southwest Environmental Resources (Southwest) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Fort Bend County. Specifically, Manvel Terrace seeks approval to acquire facilities and to transfer water service area held under Southwest’s Certificate of Convenience and Necessity (CCN) No. 11648 to Manvel Terrace’s CCN No. 12080.

On June 8, 2022, the administrative law judge (ALJ) filed Order No. 12, establishing a deadline of June 21, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a new recommendation, indicating whether the applicants have complied with Texas Water Code § 13.301 and Texas Administrative Code § 24.239. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On May 31, 2022, Applicants filed a clarification as well as a closing agreement. Staff has made attempts to contact Southwest and have not received a response. Staff requires additional time confer with Applicants. Manvel Terrace is unopposed to Staff’s request for extension. Accordingly, Staff requests that the deadline to file a new recommendation, indicating whether the applicants have complied with Texas Water Code § 13.301 and Texas Administrative Code § 24.239 be extended to July 7, 2022.

**II. CONCLUSION**

Staff respectfully requests an order consistent with the foregoing request.
