**COMMISSION STAFF’S SECOND REQUEST FOR EXTENSION**

On July 16, 2021, Manvel Terrace Utilities, Inc. (Manvel Terrace) and the Southwest Environmental Resources (Southwest) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Fort Bend County. Specifically, Manvel Terrace seeks approval to acquire facilities and to transfer water service area held under Southwest’s Certificate of Convenience and Necessity (CCN) No. 11648.

On September 2, 2022, the administrative law judge (ALJ) filed Order No. 17, establishing a deadline of September 15, 2022, for parties to jointly file proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff contacted Applicants to follow up on the status of filing the consent forms. On September 13, 2022, Southwest filed its filed consent form therefore, Manvel Terrace requires additional time to file consent forms. Accordingly, Staff requests that the deadline for parties to jointly file proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs be extended to September 29, 2022.

**II. CONCLUSION**

Staff respectfully requests an order consistent with the foregoing request.
