ERCOT'S REPORT REGARDING OPT-OUT ENTITIES

Electric Reliability Council of Texas, Inc. (ERCOT) files this Report Regarding Opt-Out Entities to provide information to the Public Utility Commission of Texas (Commission) and to interested parties regarding the entities that have filed a notice to opt out of proceeds and uplift charges authorized by the Debt Obligation Order (DOO) entered in PUC Docket No. 52322, Application of the Electric Reliability Council of Texas, Inc. for a Debt Obligation Order to Finance Uplift Balances under PURA Chapter 39, Subchapter N, and for a Good Cause Exception.

I. ERCOT Record of Opted Out Entities & Issues for Consideration by Commission

In the Status Update ERCOT filed in this docket on November 16, 2021, ERCOT stated that it would file on November 30, 2021, a list of the eligible entities ERCOT has recorded as having filed a notice to opt out of proceeds and uplift charges authorized by the DOO. The list of entities that ERCOT has recorded as having timely filed an opt out notice, and that ERCOT will treat as opted-out entities under terms of the DOO, is attached hereto as Exhibit A. The list is broken out into three different tables: one for Load Serving Entity (LSE) opt-outs (i.e., municipally owned utilities, electric cooperatives, river authorities, and eligible Retail Electric Providers (REPs) that were set forth in the Unopposed Partial Stipulation and Settlement Agreement; one for LSEs that timely filed opt-out notices in this docket; and one for transmission-voltage customers

(TVC) that timely filed complete opt-out notices in this docket. The attached list reflects entities that showed on the Commission's Interchange as having filed an opt out notice on or before 3:00 PM CPT on November 29, 2021. Because no order has issued in this matter to extend the time for filing opt out notices, ERCOT is not considering any late-filed notices, unless ERCOT is directed to do so by the Commission.

In addition, ERCOT has included in this filing as Exhibit B a list of entities that filed an opt-out notice but that ERCOT does not intend to treat as opted-out entities, unless otherwise directed by the Commission. The attached list includes both the name of each impacted entity and the corresponding reason why ERCOT does not intend to treat the entity as an opted-out entity. For example, included in the list are entities that filed an opt-out notice stating they are eligible to opt out as a TVC, but ERCOT's systems do not reflect that the TVC's Electronic Service Identifier (ESI ID) is served at transmission voltage. Further, at least one TVC submitted an opt out notice but did not include in the notice either: (a) a signature of an authorized representative from the TVC's Retail Electric Provider (REP) to support the representation that the TVC has paid in full all invoices for usage during the Period of Emergency; or (b) internal documentation that the TVC paid in full all usage charges for the relevant ESI IDs during the Period of Emergency, along with a sworn affidavit from the executive officer who signed the opt-out request on behalf of the TVC. Additionally, some TVCs filed an opt out notice but are served currently by a Non-Opt-In Entity (NOIE); however, only TVCs served by REPs are eligible to opt out. Because entities in the

The 45th calendar day from the date the DOO was signed (October 13, 2021) was Saturday, November 27, 2021. However, because the 45-day deadline fell on a weekend, the filing deadline for TVCs to opt out in 52364 was 3:00pm on Monday, November 29, 2021.

foregoing situations did not demonstrate eligibility for opting out in their filings, ERCOT is not considering them as having opted out, unless ERCOT is otherwise directed by the Commission. Further, other TVCs are listed in Exhibit B because, as of the time of this filing, ERCOT has not received ESI ID information from the entity that would allow ERCOT to properly identify and exclude the entity from the exposure calculations ERCOT must perform pursuant to the DOO. And, as noted previously, ERCOT has excluded from the attached Exhibits entities whose opt out filings on the PUC Interchange were timestamped after 3:00 pm on November 29, 2021.

Finally, ERCOT has attached as <u>Exhibit C</u> a list of TVCs that timely submitted opt-out notices, but who requested to opt-out an ESI ID that is not currently energized. ERCOT will be treating these ESI IDs as opted-out entities, unless otherwise directed by the Commission. However, ERCOT is highlighting this list of de-energized ESI IDs to the extent the Commission may wish to consider their eligibility for opting out under the DOO.

All interested parties should be advised that—unless ERCOT is otherwise directed by the Commission or is immediately informed of an inadvertent omission by ERCOT from Exhibit A—ERCOT will use the list of entities listed in Exhibits A and C to perform the calculations required by the DOO and allocation methodology in Attachment C of the Unopposed Partial Stipulation and Settlement Agreement entered in PUC Docket No. 52322. ERCOT is required to use the allocation methodology to calculate the allocation of PURA Subchapter N proceeds for each LSE that has not opted out through the process stated in the DOO. ERCOT must file these calculations in the instant docket no later than December 7, 2021.

ERCOT respectfully requests that affected entities review the attached Exhibits carefully and *immediately* inform ERCOT, through its counsel of record below, if ERCOT inadvertently omitted from Exhibit A an eligible entity that timely filed a complete opt-out notice.

II. Retail Electric Provider (REP) Submission of TVC Meter Data to ERCOT by December 1, 2021

Per the terms of the DOO and Unopposed Partial Stipulation and Settlement Agreement, each "[REP] that is eligible and chooses to receive proceeds under Subchapter N, Chapter 39 of PURA will provide ERCOT with the interval-level settlement meter data for each of its transmission level customers (including associated ESI IDs) that have opted out." In order to give ERCOT adequate time to review this data, ERCOT requests that each affected REP provide this meter data to ERCOT no later than Wednesday, December 1, 2021.

As described in its prior Status Update, ERCOT requests that the following process be used by REPs. Exhibits A and C contain the final list of opt-out entities. Each REP should review this list and determine if it was the REP (during the Period of Emergency—i.e., February 12–20, 2021) for any TVCs on the list. If, during the Period of Emergency, a REP was the REP of record for a TVC that opted out, then that REP must provide the interval-level settlement meter data for the Period of Emergency for each opted out TVC to ERCOT on or before Wednesday, December 1, 2021. This information must be emailed to ERCOT at DataLoadingandAggregation@ercot.com with the following subject line: "52364 – TVC Opt-Out Meter Data – [Legal Name of REP/DUNS Number]." For each opted out TVC, the REP must provide the TVC's legal name, ESI ID(s), and meter data.

ERCOT notes that this meter data is being provided for the purposes of helping ERCOT accurately identify each TVC opt-out. For purposes of calculating exposure required by the DOO and the Unopposed Partial Stipulation and Settlement Agreement, ERCOT must compute exposure using data in ERCOT settlement extracts.

CONCLUSION

There have been a voluminous number of filings in this docket in recent days. While ERCOT has endeavored to provide complete and accurate information in the instant filing, the sheer volume of information that was recently filed may have resulted in inadvertent omissions in the attached lists. Should ERCOT discover any such errors, it will file an update in this docket. Further, ERCOT respectfully requests that impacted entities carefully review the information included in this filing. ERCOT stands ready to take further action, as directed by the Commission, to ensure proper completion of the processes authorized by the DOO.
