

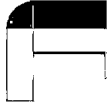

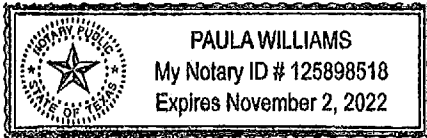
BEFORE ME, the undersigned authority, on this day personally appeared John Ritch who, being first duly sworn according to law upon his oath, deposed and stated as follows:
