ACCENT ENERGY TEXAS LP'S VERIFICATION OF EXPOSURE CALCULATION


Accent Energy Texas LP timely files this verification of its total exposure as required by the Debt Obligation Order issued in Docket No. 52322.¹ The Debt Obligation Order directed the Electric Reliability Council of Texas, Inc. (ERCOT) to file its calculation of total exposure, total exposure adjusted for transmission-voltage-customer opt-outs, and load-ratio share no later than 55 calendar days from the date of the order and directed a load-serving entity (LSE) to verify the calculation of its exposure no later than 70 days from the date of the Order.² The Debt Obligation Order was filed on October 13, 2021, which makes December 22, 2021 the deadline for LSE verifications. As stated in the attached affidavit, Accent Energy has reviewed the calculation filed by ERCOT on December 7, 2021 and has confirmed its accuracy.


Before me, the undersigned authority, personally appeared Michael Nugent, who, being by me duly sworn, deposed as follows:
