Previously submitted was a copy of the City of Goldsmith, Texas' Transmission-Voltage Customer Opt Out Notice Form signed by the City's Mayor and the VP of the REP of record on December 21, 2021.

We apologize for the delay in responding but the communications regarding the submission was incomplete. We were asked by an ERCOT representative in mid-November 2021 of the City's intentions. We replied to the representative the City wished to opt out and we thought the information flow was complete. At no time did the ERCOT representative indicate that a formal filing had to be submitted therefore we were unaware of that requirement.

As previously requested we ask the City of Goldsmith be allowed to opt out of the securitization uplift charges as stipulated in PUCT Docket No. 52364.

In the alternate if the opt out request is denied please find enclosed with this letter the City of Goldsmith's signed and notarized affidavit verifying the total exposure calculation.

On October 13, 2021, the Public Utility Commission of Texas (Commission) entered a Debt Obligation Order in Docket No. 52322 to implement Subchapter N of Chapter 39 of the PURA. Among other things, the Debt Obligation Order established a deadline for each LSE to verify the total exposure calculation for the LSE filed by ERCOT in this docket on or before 70 days after entry of the Debt Obligation Order, which would be December 22, 2021. This verification is therefore timely filed.


