**MOTION TO INTERVENE
OF DC ENERGY TEXAS, LLC**

Pursuant to Procedural Rules 22.103(b) and 22.104 of the Public Utility Commission of Texas (“Commission”), DC Energy Texas, LLC (“DC Energy”) hereby files this motion to intervene in the above-captioned proceeding. DC Energy is registered as a Qualified Scheduling Entity (“QSE”) and Congestion Revenue Rights Account Holder (“CRRAH”) with the Electric Reliability Council of Texas (“ERCOT”) and regularly participates in ERCOT’s Day-Ahead Market (“DAM”) and Congestion Revenue Right (“CRR”) auctions. The instant proceeding may determine the Default Charge payments ERCOT ultimately collects from QSEs and CRR Account Holders, including DC Energy. Therefore, DC Energy has standing to intervene pursuant to 16 TAC § 22.103(b) because it has justiciable interests that may be adversely affected by the outcome of this proceeding.
