TEXAS RETAIL ENERGY LLC’S MOTION TO INTERVENE

Texas Retail Energy, LLC¹ files this Motion to Intervene and respectfully requests that Texas Retail Energy, LLC be granted party status in this proceeding.

I.

Texas Retail Energy, LLC seeks to participate in the above-captioned proceeding pursuant to Public Utility Commission (“Commission” or “PUC”) 16 TAC §§ 22.103 and 22.104. Texas Retail Energy, LLC is a retail electric provider (“REP”) certificated by the Commission to provide retail electric service in regions of Texas within the Electric Reliability Council of Texas (“ERCOT”) and who is a load-serving entity (“LSE”) and wholesale market participant that will be affected by this docket. Additionally, this parallel docket to the Debt Obligation Order in Docket No. 52322² concerns the opting out of eligible entities, and thus concerns and affects Texas Retail Energy, LLC. Therefore, Texas Retail Energy, LLC has a justiciable interest that may be adversely affected by the outcome of this proceeding and should be granted party status.
