We normally use for a household of 2 a rate of 2K to 3K gallons. None of our bill's state that any estimate was made however, until the rate change, they have not been reading the meter on a normal basis. I was informed that per a text message Hanna sent a neighbor that when they do not read they default to charge the max allowed of 5K.

We have not had any broken lines, no sprinkler system and only use the water for showers, flushing toilet and washing clothing. For cooking and drinking we use bottled water due to the smell and coloration of the water.

Also, looking at the bills the number of days is not consistent ranging from 27 days to 33 days which would affect the actual true water usage per billing period.

Another thing that happened this year in 2023, we had never been charged taxes then April of 2023 we started getting charged a tax with no notice or description. Was able to back into it as being a 1% tax rate. I have lived at this residence since August of 1979 and have never had a tax rate until April 2023.
