After the conclusion of the first part of the Rate Hearing, EHU acted on the recommendation by Marisa Wagley to enlist the help of a PUC contractor to verify the Utilities' need as it pertains to the affiliates.

A PUC contractor came to our office to review costs. Mrs. Eaves with PUC DUO reached out to Mrs. Wagley to clarify what exactly she is requesting. Mrs. Wagley apparently reiterated the need for clarification on how billing is done between affiliates. One recommendation that was offered was to report in on a monthly basis the profit/loss statements that had been done annually before. These profit and loss statements would be specific to the CCN and include only the revenue and expenses associated with the Whitewing Subdivision (CCN 12042) with the shared costs distributed equally among the 3 CCNs. See Profit & Loss Statements provided.

The annual need falls right in between the recommended cost of service of \$49,647 provided by the PUC Legal Staff, Mr. Quijano on 11-18-2022 (See filing number #67 in this docket), and also the recommended cost of service of \$55,919 provided by the PUC Legal Staff, Mr. Quijano on 6-9-2023. (See filing number #89 in this docket).

In a phone conversation with Mrs. Wagley, she indicated the current rates were calculated without the consideration of any of the common or shared expenses between affiliates. We would hope that she does not mean that EHU cannot recover these costs, only that we would need to show the costs as provided in the monthly P&L statements as shown. We hope that this will satisfy Mrs. Wagley and that her recommendation would support the evidence provided by East Houston Utilities.

We would also like to reemphasize that these requirements are in line with other communities in the area who receive revenue from both monthly bills and annual property tax.
