SOAH ORDER NO. 12

ADMITTING EVIDENCE AND REQUIRING RESPONSE

On May 20, 2024, East Houston Utilities, Inc. (EHU) and the staff (Staff) of the Public Utility Commission of Texas (Commission), and intervenors Lauren Hood, Wesley Francis, Barry Evans, and J.D. and Mona Keller (together with Staff and EHU, the Settling Parties) filed a Joint Notice of Stipulation and Agreed Motion to Dismiss, stating that the parties had reached a settlement and requesting that intervenor Gary Lechner be dismissed as a party. On June 7, 2024, the Settling Parties filed a Joint Motion to Admit Evidence and Remand. No objections were filed against either motion.

For the reasons stated below, the motion to dismiss Mr. Lechner is **DENIED**. The motion to admit evidence and remand is **GRANTED** in part. The Administrative Law Judge (ALJ) withholds ruling on the request to remand the proceeding until the July 1, 2024 deadline ordered below has passed.

II. DENYING REQUEST TO DISMISS INTERVENOR

The Settling Parties move to dismiss Mr. Lechner as an intervenor. As set out in the motion and attached affidavit, Mr. Lechner did not file direct testimony or a statement of position by either the October 28, 2022 deadline or the subsequent January 29, 2024 deadline. In addition, EHU reports that Mr. Lechner is not a current customer of EHU and has moved out of the EHU service area.

It is apparent from the administrative and evidentiary records that Mr. Lechner has not actively participated in this proceeding. The ALJ will provide a final opportunity for participation. Mr. Lechner has until July 1, 2024, to file notice in this docket stating whether he is opposed or unopposed to the Unanimous Stipulation and Settlement Agreement. If no response is received, the ALJ will grant the Settling Parties' request to remand the proceeding so that they may present their Unanimous Stipulation and Settlement Agreement to the Commission for further processing. Accordingly, the request to dismiss Mr. Lechner is DENIED.
