This letter serves as a request to cancel CCN: N0078 attached to the water well at 1118-1/2 So. Main Street, Highlands, Tx 77562. This well system is currently listed as being controlled by an agreement between individuals, Samuel Sledge and Verna B Sledge. Due to Samuel Sledge's age and deteriorating health, it is necessary for Mr. Sledge to remove himself from the agreement as well as the water system. In addition, Verna B. Sledge has passed away, leaving the water system for the well at 1118-1/2 So. Main Street under the control of Sharon Peach, executor for Verna B Sledge's estate. Sharon Peach is a customer of the 1118-1/2 S. Main St. water system. **This letter also serves as a request for a new registration number, CCN, for the remaining water system under Sharon Peach.**

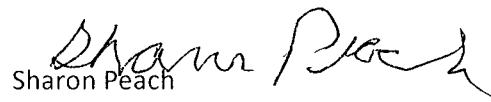
Initially, there were 14 customers on the N0078 water system. Eight of these customers, including Mr. Sledge, have drilled private wells to provide their own water and are no longer part of the N0078 water system. The properties being removed are 210 Park St., 218 Park St., 302 Park St., 310 Park St., 400 Park St., 614 Park St., 618 Park St., and 620 Park St., all in Highlands, Tx. 77562.

There will be 6 non-metered connections remaining for the new water system. Listed below are the customers at those connections for the water system. A map document showing the locations is included.

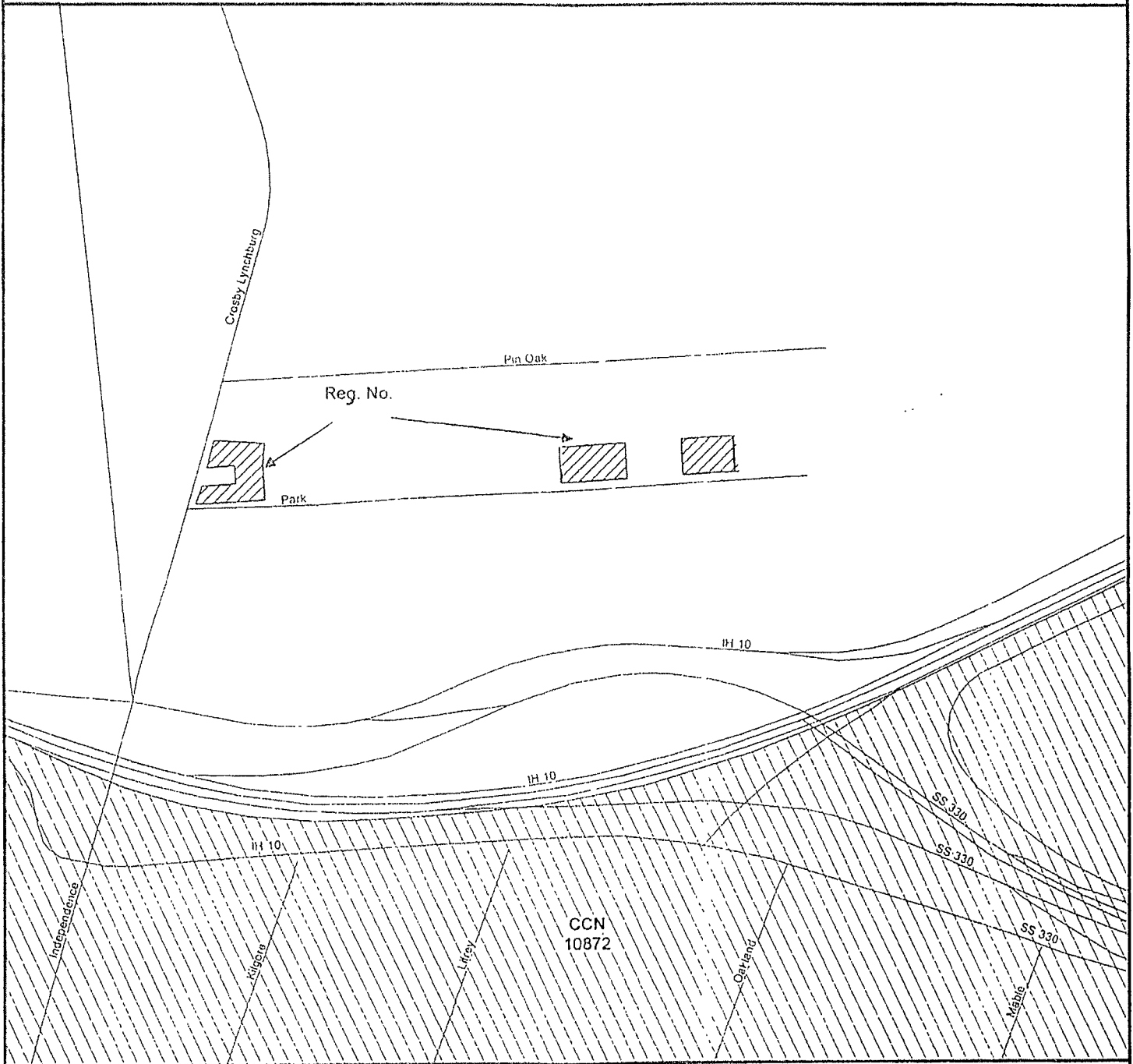

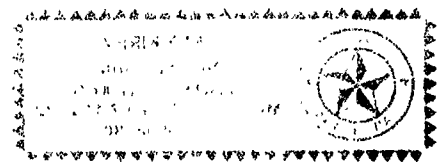

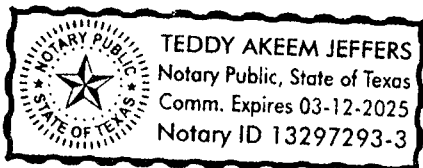
