COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

On August 3, 2021, Sharon Peach (Ms. Peach) and Samuel Sledge (Mr. Sledge) (collectively, Applicants), as Executrix of the Estate of Verna B. Sledge, filed an application to cancel an exempt utility registration number N0078 and request a new exempt utility registration for Ms. Peach.

On October 12, 2022, the administrative law judge filed Order No. 9, directing Commission Staff (Staff) to file a procedural schedule for the further processing of the application and identify what further information, if any, is necessary to process this application by November 16, 2022. Therefore, this pleading is timely filed.

I. PROPOSED PROCEDURAL SCHEDULE

Department of Utility Outreach (DUO) confirmed that a contractor was on site July 12, 2022. Applicants indicated that they intend to seek to cancel the exempt registration. Staff and Applicants have been in contact, and it is Staff's understanding that Applicant intends to file its updated application. To date, Applicants have not filed the updated application, Therefore, Staff proposes the following procedural schedule for the further processing of this docket:
