SECOND AMENDED PETITION TO CANCEL REGISTRATION 1118-1/2 SO. MAIN STREET HIGHLANDS

Comes now 1118-1/2 So. Main Street Highlands, Exempt Utility Registration No. N0078 (the "**Utility**") and respectfully requests that its registration be cancelled for the following reasons:

Background

- 1. The Utility applied for an exempt utility registration with the Public Utilities Commission on or about March 6, 2018. In approximately April 2020, the Utility ceased charging for water, and in December 2022 ceased operating.
- 2. The two operators of the Utility, Samuel Sledge and Sharon Peach, are elderly and in declining health. Neither Mr. Sledge nor Ms. Peach are a Utility user anymore. Neither operator is able to tend to maintenance and repairs.
- 3. Mr. Sledge resigned from the Utility September 1, 2020, but has assisted in winding down operations because his name is still listed as a responsible party on the registration. The only operator who is also an owner of the well, Ms. Peach, has been bedridden since approximately November 2020 and moved from the property on which the well is located in April 2022 to receive full-time care. The Utility does not have revenue to hire a professional manager.
- 4. The Utility notified each of the customers by mail on or about October 12, 2021, that the Utility would cease providing water by December 31, 2021. The Utility provided updates extending the shut off date by mail and by in-person discussions with the customers.

5. The Utility ceased operations and turned off the water supply main on or about December

31, 2022. Each of the former customers has either drilled a well for their own properties or, in the

case of three former customers, pooled resources to drill a shared well.

6. The Utility does not possess customer deposits or advance payments, and has no

distributable assets.

7. Attached hereto as **Exhibit A** is the general location map of areas formerly served by the

Utility. Attached hereto as **Exhibit B** is the detailed location map of areas formerly served by the

Utility. The Exhibits are attached for identification purposes only. The Utility has rescinded its

former request to issue a new registration number.

Prayer for Relief

8. For the foregoing reasons, the Utility respectfully requests that the Public Utilities

Commission cancel the Utility's registration.




