**COMMISSION STAFF'S CLARIFICATION IN RESPONSE TO ORDER NO. 20 AND
SUPPLEMENTAL MOTION TO ADMIT EVIDENCE**

I. INTRODUCTION

On April 3, 2023, Samuel Sledge and Sharon Peach dba 1118-1/2 So. Main Street, Highlands filed a second amended petition to cancel its exempt utility registration number N0078. On November 15, 2023, Mr. Sledge, Ms. Peach, and Commission Staff (Staff) filed a joint proposed order and motion to admit evidence.

On November 30, 2023, the administrative law judge (ALJ) filed Order No. 20, directing the Staff of the Public Utility Commission of Texas (Commission), Mr. Sledge, and Ms. Peach to clarify whether the original application, filed on August 3, 2021, and its contents should be admitted into evidence by December 22, 2023. Therefore, this pleading is timely filed.

II. CLARIFICATION IN RESPONSE TO ORDER NO. 20

The original application and its contents filed on August 3, 2021 should be admitted into evidence.
