UTILITY'S CORRECTIONS OR EXCEPTIONS TO THE PROPOSED ORDER

On December 27, 2023, the Administrative Law Judge filed the Proposed Order (the "Order") in the above-captioned matter, addressing the application of Samuel Sledge dba 1118-1/2 So. Main Street, Highlands (the "Utility") to cancel its exempt utility registration number N0078 in Harris County. The Order requires that corrections or exceptions to the Order be filed by January 12, 2024.

I. PROPOSED CORRECTIONS

- 1. The Utility proposes the following corrections to Paragraph 29 of the Order: "a. Mr. Sledge's and Ms. Peach's application and accompanying attachments, filed on August 3, 2021;" and that the remaining subparagraphs be re-lettered accordingly. The Parties jointly requested the admission of the document. It clarifies certain details cited in the Order, as further described in the immediately following paragraph.
- The Utility proposes the following corrections to Paragraph 5 of the Order: "Samuel and Verna Sledge were husband and wife and co-owners joint operators of the well exempt utility." Item 1 of this proceeding, the Utility's Application of Samuel Sledge to Cancel an Exempt Utility Registration and Sharon Peach to Obtain an Exempt Utility Registration (August 3, 2021), clarifies that Samuel Sledge and Verna Sledge were joint operators of the Utility by agreement, and that Mrs. Sledge left her control of operations to Sharon Peach. The familial relationship between Mr. Sledge is Mrs. Sledge does not appear in the record. However, Mr.

Sledge is Mrs. Sledge's nephew, and the Utility asks for any familial relationship to be stricken

as immaterial, as further described in the immediately following paragraph.

3. The Utility proposes the following corrections to Paragraph 6 of the Order: "Ms. Sledge

is now deceased and Sharon Peach is the executor of her estate. Ms. Peach and her two sisters

jointly own the well." Item 39 of this proceeding, the Utility's Response to Order No. 16

Requiring Clarification on Notice (July 12, 2023), clarifies the current ownership of the well in

the Declaration of Darlene D'Olive incorporated therein.

II. CONCLUSION

The Utility respectfully requests that the Order be revised in accordance with the

corrections proposed above.
