DEFINITIONS

- Staff 1-3** Please provide the estimated date new facilities will be required to serve the requested area.
- Staff 1-4** Please provide a copy of the Texas Commission on Environmental Quality (TCEQ) approval letter for the public water system/water treatment plant and distribution system that will provide water service to the Santa Fe subdivision.
- Staff 1-5** Please provide a copy of the Texas Commission on Environmental Quality (TCEQ) approval letter for the wastewater system that will provide sewer service to the Santa Fe subdivision.
