COMMISSION STAFF’S THIRD REQUEST FOR EXTENSION

On August 5, 2021, Liberty County Utilities, LLC (Liberty County) filed an application to obtain a water and sewer certificate of convenience and necessity (CCN) in Liberty County, Texas under Texas Water Code (TWC) § 13.254(a) and 16 Texas Administrative Code (TAC) § 24.245(h). Liberty County filed supplemental information on August 6, 2021, October 5, 2021, October 6, 2021, November 29, 2021, February 21, 2022, March 2, 2022 and March 30, 2022.

On April 6, 2022, the administrative law judge (ALJ) filed Order No. 5, establishing a deadline of May 20, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a final recommendation on the application. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Due to Staff reassignments, Staff requests this extension so that it may complete its review of the supplemental documents filed on March 30, 2022. Therefore, Staff requests that the deadline to file a final recommendation on the application be extended to June 3, 2022.

II. CONCLUSION

For the reasons discussed above, Staff respectfully requests that its deadline to file comments on the administrative completeness of the application and notice be extended to June 3, 2022.
