JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

On August 5, 2021, Liberty County Utilities, LLC (Liberty County) filed an application to obtain a water and sewer certificate of convenience and necessity (CCN) in Liberty County, Texas under Texas Water Code (TWC) § 13.254(a) and 16 Texas Administrative Code (TAC) § 24.245(h). Liberty County filed supplemental information on August 6, 2021, October 5, 2021, October 6, 2021, November 29, 2021, February 21, 2022, March 2, 2022 and March 30, 2022.

On September 21, 2022, the Office of Policy and Docket Management (OPDM) requested identification of the location in the evidentiary record of the capital improvements plan required by Texas Water Code § 13.244(d)(3). OPDM requires that the if the evidence in the record does not include the required capital improvements plan, a motion to admit the additional evidence should be filed by September 27, 2022. Therefore, this pleading is timely filed.
