**JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE**

On August 5, 2021, Liberty County Utilities, LLC (Liberty County) filed an application to obtain a water and sewer certificate of convenience and necessity (CCN) in Liberty County, Texas under Texas Water Code (TWC) § 13.254(a) and 16 Texas Administrative Code (TAC) § 24.245(h). Liberty County filed supplemental information on August 6, 2021, October 5, 2021, October 6, 2021, November 29, 2021, February 21, 2022, March 2, 2022, March 30, 2022 and November 21,2022.

On October 20, 2022, the Commission filed an order remanding this docket to Office of Policy and Docket Management (OPDM). On remand, Liberty County Utilities must file and seek admission of loan approval documents or firm capital commitments and a capital improvements plan. These filings and a motion to admit them into evidence must be submitted by Monday, October 24,2022. On November 9, 2022, the deadline was extended to November 28, 2022.
