COMMISSION STAFF'S RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS, NOTICE, AND PROPOSED PROCEDURAL SCHEDULE

On August 10, 2021, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and the Leon Springs Utility Company, Inc. (Leon Springs) (collectively Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Bexar County. The applicants seek approval to sell and transfer all of Leon Springs's wastewater system under Certificate of Convenience and Necessity (CCN) number 20614 to CSWR-Texas. The requested area includes 1,209 customer connections and approximately 1,419 acres. The Applicants filed supplemental information on August 24, 25, 26, 30 and 31, 2021.

On August 12, 2021, the administrative law judge filed Order No. 1, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application, proposed notice, and propose a procedural schedule by September 10, 2021. Therefore, this pleading is timely filed.

I. ADMINISTRATIVE COMPLETENESS

Staff has reviewed the application and supplemental information and, as detailed in the attached memoranda from Patricia Garcia of the Commission's Infrastructure Division, and Fred Bednarski of the Commission's Rate Regulation Division, Staff recommends that the application be found administratively complete. Staff's recommendation on administrative completeness is not a comment on the merits of the application.

II. NOTICE

At this time, Staff recommends that the Applicants proceed with providing public notice to all current customers, neighboring utilities, political subdivisions, and other persons listed in Ms. Garcia's attached memorandum using the notice form provided by Ms. Garcia. Along with each individual notice, Staff recommends that the applicants provide an accurate map delineating the requested service area.

Once notice has been provided, Staff recommends that the applicants file proof of notice as described in Ms. Garcia's attached memorandum, including an affidavit specifying the name and address of every person and entity to whom notice was provided, the date that the notice was provided, and a copy of the map provided with the notice. Finally, Staff recommends that the applicants use the attached notice and affidavit to meet these requirements.

III. PROCEDURAL SCHEDULE

Staff recommends that the application be found administratively complete; therefore, Staff proposes the following procedural schedule:

Deadline for the applicants to file with the Commission signed affidavits that the notice was given along with a copy of the notice and map sent to the affected parties	October 11, 2021
Deadline for Staff to file a recommendation on sufficiency of notice	October 21, 2021
Deadline to intervene	30 days after notice is issued

IV. CONCLUSION

For the reasons detailed above, Staff recommends that the application be found administratively complete, that the applicants be directed to provide notice as described in the attached memorandum, and that the proposed procedural schedule be adopted. Staff respectfully requests the entry of an order consistent with these recommendations.

On August 10, 2021, CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) and the Leon Springs Utility Co., Inc. (Leon Springs) (collectively Applicants) filed an application for sale, transfer, or merger (STM) of facilities and certificate rights in Bexar County, Texas, under Texas Water Code (TWC) § 13.301 and 16 Texas Administrative Code (TAC) § 24.239.

Specifically, CSWR-Texas, Certificate of Convenience and Necessity (CCN) No. 21120, seeks approval to acquire facilities and to transfer all of the sewer service area from Leon Springs under sewer CCN No. 20614. The requested area includes 1,209 customer connections and approximately 1,419 acres, all of which will be transferred from CCN No. 20614 to CCN No. 21120

Based on the mapping review by Gary Horton, Infrastructure Division, the maps submitted on August 10, 2021 are sufficient. Based on my technical and managerial review of the additional information filed on August 25, 2021, I recommend that the application be deemed administratively complete. I further recommend that the Applicants be ordered to do the following:

- 1) Provide notice of the application by first-class mail to the following:
 - a. Cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area:
 - Canyon Regional Water Authority;
 - City of San Antonio;
 - San Antonio River Authority; and
 - San Antonio Water System (CCN No. 20285)

- b. The county judge of each county that is wholly or partially included in the requested area:
 - Bexar County Judge
- c. Each groundwater conservation district that is wholly or partially included in the requested area:
 - Edwards Aquifer Authority; and
 - Trinity-Glen Rose Groundwater Conservation District
- d. Any affected customers, and other affected parties in the requested area.

Addresses can be obtained from the Water Utility Database, http://www.puc.texas.gov/watersearch. District information and addresses can be obtained from the Texas Commission on Environmental Quality's (TCEQ) website, http://www14.tceq.texas.gov/iwud/.

- 2) Provide notice using the attached notice form(s).
- 3) Provide a copy of the map(s) deemed sufficient during administrative review delineating the requested area with each individual notice to neighboring utilities, other affected parties, and customers.
- 4) File in the docket copy of notice and the map(s) deemed sufficient during administrative review along with the signed affidavit specifying every person and entity to whom notice was provided, and the date that the notice was provided.

Staff may determine that additional information is needed to make a final recommendation in this docket. If additional information is needed, Staff may send requests for information (RFI) to CSWR-Texas and Leon Springs. CSWR-Texas and Leon Springs will have 20 days from the receipt of the RFI to respond.

On August 10, 2021, CSWR-Texas Utility Operating Company, LLC and Leon Springs Utility Company, Inc. filed an application for the sale and transfer of facilities and certificate rights in Bexar County under the provisions of Texas Water Code § 13.301 and 16 Texas Administrative Code (TAC) § 24.239 and 24.238.

I reviewed the answers provided to questions 4, 10, 11, 12, 14, and 15 of the application. I did not identify any deficiencies in those answers for purposes of determining whether the application is administratively complete. Therefore, I recommend that the Commission deem the application administratively complete from a financial perspective.

The application proposes the addition of approximately 1,419 acres to CCN No. 21120.

This transaction will not have an effect on the current customer's rates and services.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
