**ORDER NO. 6  
AMENDING PROCEDURAL SCHEDULE  
AND GRANTING GOOD CAUSE EXCEPTION**

This Order addresses Commission Staff’s request to amend procedural schedule and for a good cause exception to shorten the intervention deadline in this matter. On November 11, 2021, the City of San Antonio confirmed receipt of notice and stated that “it does not intend to intervene in the [Commission] proceedings.” In view of this representation, Commission Staff submits that there is good cause to shorten the intervention deadline in this matter.<sup>1</sup>

The administrative law judge grants the good cause exception. The amended procedural schedule applies:

<b>Event</b>	<b>Date</b>
Notice complete	October 21, 2021
Deadline to intervene	November 11, 2021 <sup>2</sup>
Deadline for Commission Staff to request a hearing, or file a recommendation	December 14, 2021
If no hearing is requested, deadline for parties to file a response to Commission Staff’s recommendation on final disposition	December 30, 2021
Deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing transaction to proceed	January 13, 2022
