**LEON SPRINGS UTILITY COMPANY AND CSWR-TEXAS UTILITY OPERATING  
COMPANY, LLC’S CLARIFICATION REGARDING CORPORATION NAME AND  
STATUS AND REQUEST TO RESTYLE DOCKET**

COME NOW Leon Springs Utility Company (“Leon Springs”) and CSWR-Texas Utility Operating Company, LLC (“CSWR-Texas”), and file this Clarification Regarding Corporation Name and Status and Request to Restyle Docket. Commission Staff has brought to the applicants’ attention that there is a typo in the application and style of this proceeding. Both the application and the style of this proceeding refer to Leon Springs as “Leon Springs Utility Company, Inc.,” consistent with the identity of this utility in the Public Utility Commission of Texas database.<sup>1</sup> However, Leon Springs is registered with the Texas Secretary of State’s office as “Leon Springs Utility Company,” which is the correct name for Leon Springs as shown in Exhibit A. The Commission’s online utility database, therefore, is in error.

The Applicants hereby confirm that references to “Leon Springs Utility Company, Inc.” in this application and on the Commission’s online database are references to the applicant Leon Springs and not any other similarly named entity. To the best of the Applicants’ knowledge, there is no entity registered in Texas with the name “Leon Springs Utility Company, Inc.”

In addition, the Applicants request that the proceeding be restyled to correct this error as follows: *Application of CSWR-Texas Utility Operating Company, LLC and Leon Springs Utility Company for Sale, Transfer, or Merger of Facilities and Certificate Rights in Bexar County.*



I, the undersigned natural person of the age of eighteen (18) years or more, acting as an incorporator of a corporation under the Texas Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is LEON SPRINGS UTILITY COMPANY.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is to carry on any lawful business for which corporations may be incorporated under the Texas Business Corporation Act, including but not limited to collection, treatment, handling, transportation and disposal of sewage for domestic, commercial, and other purposes.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is One Million (1,000,000), all of which shall be common shares with a par value of One Dollar (\$1.00) each.
