Staff 3 -3 Please provide the number of connections and capacity planned for each phase of the built-out for each of the water plants.

Response 3-3 In addition to information filed on 4/27/2022, please accept the following information as it relates to the map provided in Response 3-4. The area marked Tract 3-620 Acres is currently being developed. The area to the east of the Pine Rock (far left side of the map) is also being currently developed. The area to the north, White Rock Acres and White Rock Land are slated to begin construction within the year. The area marked 3M Development and Legacy Pines will follow that.

Development in this area has been brisk and intensive. Literally, all of Montgomery County has been seeing development at rates never seen before. Please let me know if you have any additional questions.

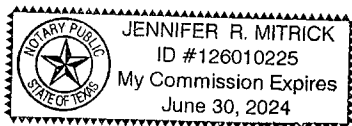
