JOINT SUPPLEMENTAL STATUS REPORT

On August 17, 2021, Crystal Springs Water Company, Inc. (Crystal Springs) filed an application to amend Certificates of Convenience and Necessity (CCN) in Montgomery County. Crystal Springs holds water CCN No. 11373 and sewer CCN No. 20906. The requested service area consists of 2,364 acres, zero existing connections, and 3,655 proposed connections.

On May 17, 2022, the administrative law judge (ALJ) filed Order No. 6, establishing a deadline of July 8, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental status report. Therefore, this pleading is timely filed.

I. SUPPLEMENTAL STATUS REPORT

To date, Crystal Springs is still pending approval from the Texas Commission on Environmental Quality on the second phase of its water distribution lines. Further, a new financial analyst for Staff has recently been assigned in this docket and requires additional time to review the financial documents and RFI responses before Staff can proceed with the creation of the final documents and recommendations in this docket. As such, Staff respectfully requests that Crystal Springs and Staff be given a deadline of July 18, 2022 to file a second supplemental status report or to propose a procedural schedule for further processing.

II. CONCLUSION

Crystal Springs and Staff respectfully request the entry of an order consistent with above request.
